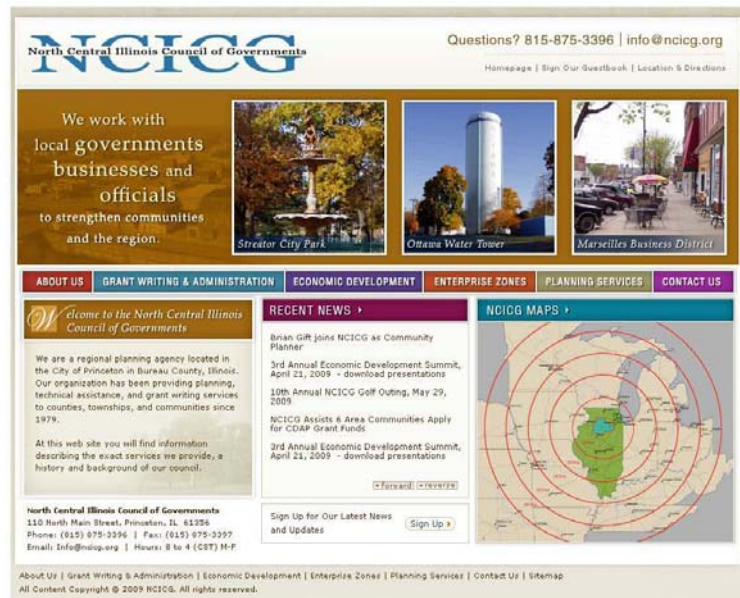

The honorees (representing a combined **204 years of service** as mayor/village president and trustee/alderman/councilman), received plaques recognizing their many years of service. Each Achievement Award was inscribed...

“In Grateful Appreciation for Dedicated Service to the People of their respective city/village and their Support of the North Central Illinois Council of Governments.”

Over the 30 years, NCICG wrote and administered a total of approximately **60 grants** for a variety of projects in these **seven (7) communities**. Total grant funds awarded equals **\$14,732,157**. These grants resulted in a total of **\$87,645,210 of public and private funds** being invested in these seven (7) communities. This figure does not include the peripheral benefits and expenditures that occur because of projects like this (e.g. jobs created).



The evening's program also included a presentation by **Carol Kulek** from the Department of Commerce and Economic Opportunity (DCEO), Bureau of Energy/Recycling. Her presentation, entitled: "Energy Efficiency Resources for Local Governments," outlined for the communities how the DCEO and NCICG will be working with Federal Recovery funds to help their communities become more energy efficient. Ms. Kulek made the formal announcement that **NCICG will be administering over \$900,000 in Federal Recovery funds for the statewide Energy Efficiency Community Block Grant Program**. The funds will be granted to local governments in the region through a competitive application process.

Carol was introduced by past-Executive Director of NCICG, **Doug McDermand**. Doug gave a brief history of NCICG highlighting some of the major accomplishments.

A Service Award was presented to **Kevin Lindeman**. Kevin had worked a little over three (3) years, left to work in the private sector and returned in January 2000. This coming January 3, 2010 he will have completed 10 (a total of 13.3 years) continuing years of dedication and service to NCICG and all of the communities. Kevin was also awarded the "Get 'er done" recognition.

Samantha Warren from Debbie Halvorson's office made a presentation that included a framed certificate: "This flag which was flown over the U.S. Capital is in recognition of North Central Illinois Council of Governments for its 30 years of community service... signed Debbie Halvorson, Member of Congress, 11th District of Illinois."

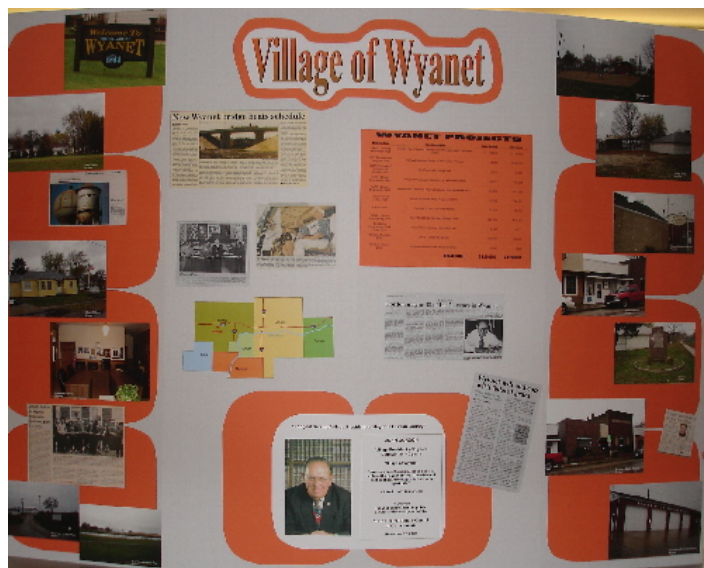

NCICG... 2009 In Review

What a year! 2009 presented us with the American Recovery and Reinvestment Act (ARRA), an Illinois Capital Bill, applications for ARRA infrastructure projects, and a new regional Energy Efficiency Block Grant program, just to mention a few. Here are some of the highlights:

- New staff additions during past year... added **Brian Gift, Community Planner**. Brian, a University of Illinois graduate, is working on comprehensive plans, mapping, zoning and energy efficiency projects.
- A region-wide call for projects by NCICG resulted in a comprehensive list of **205** potential projects totaling **\$359,717,798.00**. The list was presented to: the IL Strategic Infrastructure Task Force; Federal and State Agencies; Federal and State Legislators; Illinois Capital Bill Hearing panels, and several State and National Organizations that issued "Calls for Projects."
- **ENERGY EFFICIENCY COMMUNITY BLOCK GRANTS** - New program through DCEO Bureau of Energy & Recycling. NCICG will administrate the program our service area. Competitive grants will be available to local governments to implement a variety of energy efficiency programs and projects. Program will roll out in early 2010.
- NCICG assisted with a plan to launch a **regional broadband project**. Effort was spearheaded by City of Ottawa. Also joining the effort is LaSalle County, the City of Oglesby, the City of Peru and the City of LaSalle.
- Planning Projects: **Comprehensive Plans** are nearing completion for the City of Oglesby and Putnam County.
- **Zoning** map for Sheridan has been completed and an update of the McNabb Zoning Ordinance is underway.
- **Enterprise Zones** – NCICG Administers two (2) Zones: **Bureau/Putnam EZ** and **Marshall County EZ**. GIS maps have been completed for the Marshall County EZ and will be soon prepared for the Bureau/Putnam EZ. The NCICG Economic Development District funded this effort.
- **HSTP** – IDOT CONTRACT– 2007-2009 – Three (3) year contract to develop a Human Services Transportation Plan for Region 1 (Boone, Carroll, Jo Daviess, Stephenson & Winnebago Counties) and Region 3 (Bureau, Dekalb, Kendall, LaSalle, Lee, Ogle, Putnam). Purpose is to coordinate and advance transportation services for elderly, disabled and low-income people. Plans are complete and are being implemented.
- The **Oglesby** McPhedran Park Grant has been funded through the IL Department of Natural Resources, Open Space and Land Acquisition Program. Work continues on the **Princeton** Zearing Park expansion. An acquisition grant has been submitted for the City of **LaSalle** to acquire a fifty-two (52) acre parcel for future park development.
- **Economic Development**
 - ✓ **3rd Annual Summit - 2009** held at Celebrations in LaSalle on May 22.
 - ✓ **4th Annual Summit - 2010** - TBA.
 - ✓ EDD has several grant applications for **EDA** Public Works and Economic Development funds submitted.
 - ✓ **Webinars** were hosted at IVCC and Marshall County, NIU Extension. Partnerships continue with: North Central Illinois Logistic Council, NCI Works, Illinois River Road National Scenic Byway, and others.
 - ✓ The EDD is funding a **new NCICG website** with a significant economic development component.
- **NCICG and IVCC have formed a new partnership**. The two entities have worked on a grant application to the U.S. Department of Energy. NCICG is available to assist the College with other grants as needed. Many other projects and collaborations have been discussed and will be explored.
- **Recycling** – The Marshall/Putnam Recycling Program observed Arbor Day (a nationally celebrated observance that encourages tree planting and care) by giving away trees at locations in both counties. Other highlights: The Marshall/Putnam Fair booth and a new public information campaign.
- **CDAP Grants** ... Communities awarded grants from February 2009 funding round: Kinsman, Princeton, Tiskilwa and Wenona.
- **CDAP Grants** ... Communities awarded grants from June 2009 ARRA funding round: Carbon Hill, Diamond, and Grand Ridge.
- **10th Annual Golf Outing** was held on May 29 at Spring Creek Golf Course in Spring Valley.
